– TEACHER TRAINING STUDENTS –

The MEXT (Ministry of Education, Culture, Sports, Science, and Technology) offers scholarships to foreign students who wish to conduct research on school education at Japanese universities under the Japanese Government (MEXT) Scholarship Program for 2014 as follows:

1. QUALIFICATIONS

(1) Nationality:	Thai.
	An applicant who has Japanese nationality at the time of application is not eligible. Selection is
	conducted at facilities such as the Japanese Embassy/Consulate General (hereinafter "Japanese
	legation") located in the country of the applicant's nationality. (This shall not necessarily be applied in
	cases where one embassy covers multiple nations.)
(2) Age:	Not more than 35 years old (must be born on or after April 2, 1979.)
(3) Academic Background:	Applicants must be a graduate of universities or teacher training schools and have worked as a teacher
	at elementary or secondary educational institutions or teacher training schools in their home
	countries for at least five years in total, as of April 1, 2014. (In-service university faculty members are
	not eligible.)
(4) Academic Records:	Applicants' academic records is no less than 2.75 in grade point average (G.P.A.) at the undergraduate
	level. Only teachers teaching in the field of Japanese language must have academic records no less than
	2.50 in grade point average (G.P.A.).
(5) Japanese Language Ability:	Applicants must be willing to learn Japanese. Applicants must be interested in Japan, and be willing to
	deepen the understanding of Japan after arriving in Japan. Applicants must also have the ability to do
	research in Japanese and adapt to living in Japan.
(6) Health:	Applicants must be free from any mental or physical disability that would be an impediment to the
	pursuit of study in Japanese University.
(7) Arrival in Japan :	Applicants must definitely be able to arrive in Japan within two weeks counted from the starting day of
	the study course set by the university in Japan (usually October) and the period set by the accepting
	university . (If the applicant arrives in Japan before the designated period for any reasons, their
	travel expenses to Japan will not be paid. And, if the applicant cannot arrive in Japan during the
	designated period, the applicant must resign.)
(8) Visa acquisition:	Applicants must acquire a "College Student" (ryugaku) visas before entering Japan. They then enter
	Japan with the "College Student" (ryugaku) residence status. Moreover, in exceptional cases when
	successful applicants have been residing in Japan before their acceptance under a status other than
	"College Student" and are to change their visa status within Japan, they must acquire a "College Student"
	visa by the end of the month prior to the month in which they are scheduled to start receiving the
	scholarship. Furthermore, note that those who change their visa status to gone other than "College
	Student" after arriving in Japan will also lose their qualifications to be Japanese Government Scholarship
	recipients from the date when they change their visa status.
(9) Miscellaneous:	Scholarship recipients must return to their home country as teacher right after the end of the scholarship
	period, and be able to apply the results of their research on school education in Japan to their teaching in
	their home country.
(10) Any applicant who meets a	any or all of the following conditions is not eligible. If identified after the start of the scholarship period,

(10) Any applicant who meets any or all of the following conditions is not eligible. If identified after the start of the scholarship period, the applicant will be required to withdraw from the scholarship.

- 1. Those who currently qualify as military personnel or military civilian employees.
- 2. Those who can not arrive in Japan during the period designated by the accepting university.
- 3. Applicants who have been awarded a Japanese Government Scholarship in the past will not be selected as recipients unless at least three years have passed since the first of the month following the final receipt of the previous scholarship, as of October 1, 2014.
- 4. Those who are already enrolled at Japanese universities with "College Student" visa status, or those already enrolled or are scheduled to be enrolled in universities in Japan as non-scholarship students, from the date of application in their home countries to before the first receipt of the scholarship.
- 5. Recipients of scholarships from other institutions than MEXT, including government institutions in their home countries.

(11) Study courses implemented:

Study/training is implemented only for university/training courses listed in the booklet "Course Guidebook for Teacher Training Students," distributed at Japanese legations overseas. (The Course Guidebook will also be available on the MEXT website: http://www.mext.go.jp/a_menu/koutou/ryugaku/boshu/1343641.htm)

2. TERM OF SCHOLARSHIP

The term is the period necessary to complete each university's training course and should be between October 2014 (or the starting month of the study course) and March 2016. (Extension of the term is not allowed.)

3. SCHOLARSHIP BENEFITS

 Allowance: <u>The amount of the scholarship disbursement per month for the 2014 academic year has yet to be determined. However,</u> <u>the actual amount for the 2013 year for reference is 143,000 yen per month.</u> (The monetary amount each year may be <u>subject to change because of budgetary reasons.</u>)

In case that the recipient researches in a designated area, 2,000 or 3,000 yen per month will be added. However, the scholarship is cancelled in principle if the recipient is absent from the university for an extended period.

The scholarship will be cancelled in principle in the following situations. And, if the recipient has been receiving the scholarship despite his/her falling under any of the following situations, the recipient will be ordered to return the amount of scholarship that he/she received during the period wherein he/she was involved with any of the following situations.

- 1. The recipient is judged to have made a false statement on his/her application.
- 2. The recipient has violated any article of his/her pledge to the Minister of Education, Culture, Sports, Science and Technology.
- 3. The recipient has been subjected to disciplinary action like expulsion or removed from registration by the university or institution where preparatory Japanese-language lessons are undertaken.
- 4. It has been determined that it will be impossible for the recipient to complete the study course within the standard time period because of poor academic grades or suspension from the university.
- The recipient's status has been changed into one other than "College Student as defined in the Appended Table I-4 of the Immigration Act."
- 6. The recipient has received a scholarship from another institution (excluding those specified as being for research expenditures).

(2) Transportation

- a. Transportation to Japan: The recipient will be provided, according to his/her itinerary and route as designated by MEXT, with an economy-class airplane ticket from the international airport nearest to his/her home address* to the New Tokyo International Airport (or any other international airport that the appointed university uses as a normal route). Expenses such as inland transportation from his/her home address to the international airport, expenses within Japan such as the airport tax, airport usage fees and special taxes on travel will NOT be provided and should be borne by the student. (*The applicant's official home address will be determined by their address as indicated on the application form.).
- b. Transportation from Japan: A recipient who returns to his/her home country within the fixed period after the expiration of his/her scholarship will be supplied, upon application, with an economy-class airplane ticket for the travel from the New Tokyo International Airport (or any other international airport that the appointed university uses as a normal route) to the international airport nearest to his/her home address*.
- (Note) Any aviation and accident insurance to and from Japan shall be borne by the recipient. In addition, the airport must be one in the country of the recipient's nationality.
- (3) Tuition and Other Fees : Fees for the entrance examination, matriculation and tuition at universities will be paid by the Japanese Government.

4. DOCUMENTS TO BE SUBMITTED

Applicants must submit the following documents together to Bureau of International Cooperation, Office of the Permanent Secretary, Ministry of Education in Thailand by the required date. The submitted documents will not be returned.

*(Note 1) <u>These documents must be written in Japanese or English</u>, or translations in either of these languages should be attached.
*(Note 2) Regarding the diploma mentioned in (4,5), a photocopy thereof may be an acceptable substitute. However, this should be attested by the school authority concerned.

*(Note 3) No application will be considered unless the aforementioned application and all other documents are fully and correctly completed.

5. SELECTION

(1) The Embassy of Japan will carry out the primary selection from among applicants by means of a review of the submitted documents, a written examination, and an interview.

The written examinations will be English and Japanese Language. Please note that all applicants must sit for the Japanese Language test. The Japanese Language score will be used for reference only.

- (2) Results of the primary selection will be notified on the date separately designated by the Embassy of Japan.
- (3) Applicants who pass the primary selection will be recommended by the Embassy of Japan to MEXT.
- (4) MEXT will conduct a secondary (final) selection for the applicants recommended by the Embassy of Japan and decide the scholarship recipients.

(Note) In order to judge the level of language education needed for successful candidates after their arrival in Japan, written examinations in Japanese and English will be given for reference purposes at the time of the primary selection.

6. PLACEMENT IN AND SPECIALIZED TRAINING AT UNIVERSITIES

- (1) MEXT, in consultation with the university concerned, will decide on the university in which each recipient shall be enrolled by taking into consideration his/her Japanese Language ability and the specialized courses he/she wishes to be enrolled in. Objections regarding university placement will not be accepted.
- (2) The training at universities will be conducted in Japanese, in principle.
- (3) The recipients whose Japanese language ability is insufficient will undergo Japanese-language education in a Japanese language study course at the appointed university or at a university designated by MEXT. Japanese -language education is generally provided for six months at the beginning of the program, but some of the accepting universities may conduct Japanese language education parallel to the training.
- (4) The training mainly consists of educational administration (such as educational administration and finance, school management), educational methods (examples: classroom teaching, learning system theory, curriculum, and educational assessment), specialized subject research (examples: mathematics, physics, chemistry, and gymnastics), and observational tours and practice (examples: class observation, participation in special educational activities, and tours of educational research facilities). Guidance plans will be organized flexibly according to the research themes the students wish to study.
- (5) A recipient who has completed a specified course at the university concerned will be given a certificate. However, the purpose of this scholarship program is not to obtain a diploma. Therefore, a recipient cannot be enrolled in an undergraduate course at a university or a master's or doctorate course at a graduate school as a Japanese-government-sponsored international student during the term of or right after the completion of this program.

- 7. NOTES
 - (1) Each recipient is advised to learn the Japanese language and to acquire some information on Japanese weather, climate, customs, university education and conditions in Japan, as well as about the difference between the Japanese legal system and that of his/her home country before departing for Japan.
 - (2) The recipient should bring approximately US \$2,000 or the equivalent to cover immediate needs after arrival in Japan
 - (3) Accommodations:
 - 1. Residence halls for international students provided by the universities

Some universities have residence halls for international students. The recipients enrolled at national universities where such facilities are available may reside, if they so desire, at these residence halls under certain conditions. However, because of the limited number of rooms, some of these facilities may not be able to accommodate all the students who wish to live in them.

2. Private boarding houses or apartments

Those who are not able to find accommodation in the aforementioned facilities may live in regular dormitories of the university or in a private boarding house/apartment introduced by the university.

It is very difficult for recipients with dependents to find appropriate housing in Japan. The recipient is requested to arrive in Japan alone first to secure housing before having his/her spouse and/or family come over to Japan.

- (4) In addition to the information determined in this guideline, matters which are necessary to implement the Japanese Government Scholarship are determined by the Japanese Government.
- (5) More detailed information on this scholarship program is available at the Embassy of Japan.
